The Management Board of Zakłady Automatyki "POLNA" S.A. in Przemyśl hereby presents the life stories of selected members of the Supervisory Board appointed by the Annual General Shareholders Meeting of Zakłady Automatyki "POLNA" S.A. on 20<sup>th</sup> June 2011.

Grzegorz Hayder, aged 43

He holds a degree of doctor of economics, obtained in 1998 at the University of Economics in Katowice (then called Akademia Ekonomiczna). He first gained professional experience at the Cracow University of Economics as an assistant in the years 1991-1992, during which period he had a scholarship at Carleton University in Ottawa, Canada, at the School of Business there. Then, in 1992 he started work in a Division of Bank Polska Kasa Opieki SA in Przemyśl, working successively as an inspector, Section Manager, Team Manager and Head of Department. Since 2002, he has had the position of Director of Division, managing units with various competences, among others related to evaluation of credit risk concerning involvement of individuals and business entities. He served that function until the end of January 2009.

Simultaneously, he conducted lectures and seminars at various universities in Podkarpacie region (Rzeszow University of Technology, State School of Higher Vocational Education in Jarosław, School of Law and Public Administration in Przemyśl and others).

At the beginning of 2009, he started work on the position of Financial Director of Kazar Footwear Sp. z o.o. in Przemyśl.

Since December 2010, he has been serving the function of Deputy Mayor of the City of Przemyśl.

Since 2009, she has been performing the function of the Supervisory Board Secretary in the company Energopol Trade S.A. and the Secretary of the Supervisory Board in the company Energopol Warszawa S.A.

### 3. Elżbieta Opawska, aged 38
